Discharge planning should result in a written document, a discharge plan. The discharge plan should be a comprehensive tool and should be based on: where and how a patient will get care after discharge; what the patient and his or her support groups (family, friends, hired help) can do to facilitate recovery;

Plan, structure, and phase discharge. The guidance states that the transition from one service to another may evoke strong emotions and reactions in people using mental health services. As a result, services should ensure that:

### **Poor discharge practice leading to 'unnecessary patient ...**

When people are discharged home from an ER, same day surgery, overnight hospital stay, discharge plans involve medical follow-up appointments, dietary restrictions, medications, physical limitations, specific warning signs to watch for. Usually very short-term with limited follow-up.

### **Psychiatric Hospital Discharge - Resources and Information ...**

Discharge planning is a complex activity, particularly in the context of new services offered outside hospital, like intermediate care, and having a population with more older people, who often have extremely complex care needs. However, effective discharge planning is crucial to ensure timely discharge and continuity of care.

### **The key principles of effective discharge planning ...**

Ideally, discharge planning starts as soon as you are admitted to hospital. And ideally, it also involves you and your family, as well as hospital staff. In some cases, it is simple. For example, you might be expected to leave hospital in 2 days with certain medications, and you might be told to see your GP 2 days after you get home.

Discharge planning for an inmate with a mental illness or chemical dependency should be initiated at least 90 days prior to their release. Community residential placements for these inmates should take priority as they are the most difficult to secure. Several national contact organizations are listed in attachment

Appropriate discharge planning requires thinking long-term. The focus should be on returning the individuals to their prior independent living state while recognizing they may need short-term supportive care to ensure health, safety and wellbeing.

### **Working with Older Adults and People with Disabilities ...**

Make sure hospital staff members consider your full range of needs when creating your discharge plan. If you are returning home, hospital staff must evaluate your need for home health care, meal delivery, caregivers, durable medical equipment (DME), and changes to your home to ensure safety.

The DASH plan is low in sodium, unhealthy fats, and total fat. It is high in potassium, calcium, and fiber. Exercise to maintain a healthy weight. Exercise at least 30 minutes per day, on most days of the week.
